## CENTRE COORDINATOR/LIAISON OFFICER REPORT

Amit Barkay (Centre Liaison Officer) reported that the kangaroo statue was missing from the school courtyard. The gate was forced, suggesting it may have been stolen.

## TREASURER'S REPORT

The Treasurer reported that following a series of positive months since August 2013, the accounts were in good shape, with $\$ 10,270.49$ in the working account at the end of December.

The Committee endorsed the expenditure on a new vacuum cleaner previously agreed by email exchange.

## DEVELOPMENT ISSUES

Meeting with Chief Minister's staff. There was some discussion on the approach to be taken at the meeting on Wednesday $8^{\text {th }}$ Jan. It was agreed that the following points should be emphasised:

- Planning should be holistic, and for the whole suburb
- Public transport and other infrastructure should be considered in conjunction with construction planning
- There has been insufficient consultation over redevelopment of the School site
- Physical progress appears to be occurring before the Territory Plan Variation has been done
- Traffic is an issue in Melba St, regardless of the findings of the Traffic Study.


## PARTIES AT THE SHOPS

It was agreed that we would be involved with this activity.

## Action: Amit Barkay to contact Amy Moon to find out what is involved. DCC tenants to be contacted to see who wishes to be involved.

There was some discussion of how running the Parties at the Shops might impact on the Spring Fair. It was suggested that given the work schedule on upgrading the shops, the opening of the shops could be later than the middle of the year, providing an opportunity for a 'Fair' to coincide with the opening.
